AMENDMENT TO TENDER NOTIFICATION

Ref.1. CCW/CR.77/10 -11, Dated: 23.02.2011.

Ref.2. CCW/CR.77/10 -11, Dated: 23.03.2011

In the tender notification cited at Ref 2 above, in accordance with the Clause at Sl. No 11, the last date for submission of tender was amended to 12.04.2011. It is considered necessary that the following amendments in the RFP are necessary and hence the following amendments are deemed to be inserted in the RFP.

- 1. Under clause 2 of RFP, in sub clause 2.1 (after the table) which reads as "The locations are subject to change to suit the convenience of CTD business process & the deputed personnel will move accordingly if there is change in location. The assignment of 3 engineers and 16 TAs in Bangalore are subject to change within Bangalore." shall stand deleted. 2.1 shall now stand amended as follows: "In some large divisions such as Belgaum, Gulburga, M'lore etc, TAs may be assigned locations outside the Divisional Headquarters on a permanent basis. Posting within the Division will be at the discretion of the Divisional head. The locations are subject to change to suit the convenience of CTD business process & the deputed personnel will move accordingly if there is change in location. Travel allowances and such other expenditure will be at the bidders cost.
- 2. In sub clause 2.2.1, "All the technical Assistants (TAs) must be First Class Pass in IT" is hereby **amended and shall read as** "All the technical Assistants (TAs) must be qualified Diploma holder in C.S, E & C, IT, IS or similar streams of IT."
- 3. Sub Clause 2.2.2 stands deleted and shall stand amended to read as follows: 2.2.2 Of the 3 engineers mentioned in Sub Clause 2.1, one Engineer must be certified MCSE(systems analyst), one Engineer must be Certified OCA (Data Base Manager) and the third Engineer must be a certified CCNA. They should have at least 3 years experience working on similar position. These 3 engineers, supported by the TAs must work as a team and should provide smooth and efficient functioning of the IT infrastructure. It shall be the bidders responsibility to ensure that relevant H.R policies etc are put in place for the team as a whole to deliver this."

- 4. Sub Clause 2.3.1 stands deleted and shall stand amended to read as follows: 2.3.1. The successful bidder shall furnish a list of TAs and Engineers being deployed to CTD. The list shall contain all the credentials of the candidates and their dates, locations of joining the CTD. The successful bidder must verify the Original certificates of the prescribed qualification and provide CTD with a copy of the attested certificates. CTD may verify the original certificates if required. CTD will assess the suitability of the deployed candidates based on their work & performance during their work. If any deployed personnel is found not suitable, at any point of time, the successful bidder shall replace such a personnel not later than fifteen days, after CTD's intimation. The successful bidder shall ensure that situation to replace personnel shall be kept to a minimum by ensuring suitability before deployment.
- 5. In clause 3, Under 'Purchase of Materials', after sub clause 3.3, another sub clause 3.4 shall be deemed to be inserted, which will read as follows: "3.4. So as to improve efficiency and reduce paper work, the Contractor, after the contract comes into effect, may get approved a price list of some goods that are most often replaced. Approval of this price list may be made by comparing the price of such goods from reputed vendors. The validity may be for a period of one year, extendable by mutual consent.
- 6. In Clause 8.3 which reads as follows "The tender document namely the RFP will be supplied to the service provider desiring to participate in this bid at a cost of Rs.100/- (Rs. one hundred only), which is non-refundable, in the form of Demand Draft drawn in favour of "Commissioner of Commercial Taxes, Bangalore" payable at Bangalore." shall stand amended to: "The tender document namely the RFP will be available in CTD website www.ctax.kar.nic.in". The other portions of Clause 8.3 shall stand unaltered.
